SIGNAGE

In the upcoming weeks the street name and 4 of the STOP signs are being replaced due to their deteriorated condition.

Additionally, new signs,, including "Towns" complex identification at each entrance and a series of vehicle rules/requirements, will be placed throughout the community.

<u>PARAMOUNT IMPORTANCE</u> The STOP sign, currently at the corner, where Jonah makes a 90* turn at the entrance to Melrose, will be moved to the exit corner of Melrose, where it should be.

To facilitate this change, 2 new TURN signs will be installed on Jonah, instructing motorists, coming from both directions regarding this corner.



REMINDERS

While optional, the intent of the <u>light sensor garage fixtures</u>, is to leave the garage switch on so the neighbourhood will be brighter and safer at night
